 - Transportation Services: met with King County and Sound Transit to prepare for huge increase in population on campus with the new transit centers by the stadium and in the U-Dist. BG Trail detour (from 15th through Rainier Vista, including Hitchcock bridge) through Mar/Apr 2016.
 - EH&S Staffing: Interviewing ergonomists should fill position in next few weeks. Should fill position of Industrial Hygienist by end of year. Diving Safety. Interviewing for Occupational Health Nurse Manager. May change Sherry Baron's position.
 - Now another wastestream: yellow sharps. These are containers for needles that came into contact with drugs. There is a website and a poster.

Guest Speaker: Siri-Elizabeth McLean of UWEM re: earthquake preparedness

- UWEM here to help mitigate against/prepare for/respond to/recover from incident. Their exercises practice running the coordination center for situational awareness and decision making.
- Preparedness pyramid work on base things first:
 - 1. Individual/Employee personal preparedness (disaster kit, out-of-area contact, family plan)
 - 2. Unit/Dept business continuity planning ("Husky Ready/BARC" plan)
 - 3. Building emergency evacuation operations plan (EEOP)
 - 4. Your campus area's Unit Response Center (URC)
 - 5. U-wide All-Hazards Emergency Management Planning Center (EMPC)
- Emergency (call 911) vs. Disaster (emergency responders overwhelmed so you must be selfsufficient)
- Earthquakes in the PNW
 - o During quake: DROP, COVER, HOLD (*not* a doorway or the fictitious triangle of life)
 - Drop to ground away from windows
 - Cover torso and neck/head
 - Hold onto desk etc
 - o Due to decent U.S. building codes, we expect bldgs to stay intact, but fear non-structural items. To mitigate, tie down or lower high-flying objects (books, lamps, pictures, plants).
 - Under-the-bed preparedness items, in drawstring bag tied to foot of bed: hard hat, headlamp, shoes, gloves, goggles, dustmask
 - Ring of Fire volcanoes form subduction zone. Nisqually quake in '01 a hiccup compared to what could expect.
 - o Harder soil on West coast don't feel quakes as far away
 - o Triple threat here in Seattle:
 - Deep (Juan de Fuca vs. N. American plate) we had 6.5, 6.8, 6.8 in '49, '65, '01

Health and Safety Committee for Group 9 (College of Engineering)

- Subduction (also Juan de Fuca vs. N. American plate) -- Cascadia Subduction
 Zone is 700 mi long, No. CA to BC expect quick tsunami.
- Coastal/Surface faults all three UW campuses are near one. Potential for tsunami max 16'.
- Liquefaction, where old water beds (valleys, where rail lines built). Now mitigating rail lines but W.S. bridge will be lost. Seattle is a lot like Christchurch NZ (liquefaction, surface faults).
- Water lines and gas lines will break (gas line breaks may cause fires)
- Transportation infrastructure will clog and have blockages so expect to stay at home or work for days. Don't drive; stay put. UW does not have stockpiles of food and water so store some at work.
- In June 2016 there is a 4-day multi-state subduction zone earthquake exercise; UW EOC participating for 2 days.
- Prevent damage caused by quake: latches on cupboards, non-skid shelf liner, quake mats under computers, furniture and large objects attached to walls. Siri can do walkthrough of workspace to spot quake damage mitigation opportunities
- All-Hazards Preparedness
 - Critical Infrastructures (all connected): personal preparedness for each sector
 - Agriculture (stockpile food, and change out supplies periodically)
 - Water (stockpile water, and change out supplies periodically)
 - Public Health and Emergency Services (take First Aid class, have supplies)
 - Information and Telecommunications (emergency radio)
 - Energy (solar panels?)
 - Banking and Finance (have some cash on hand)
 - Transportation and Shipping (know that help will take time)
 - Be prepared to be self-sufficient for 7 days
 - Emergency supplies (and maintain list of supplies for each kit):
 - Water
 - Food
 - Light
 - Communications
 - Medical supplies
 - Warmth/shelter
 - Sanitation (emergency toilet)
 - Tools/equipment
 - Entertainment
 - Personal items, like heavy-duty shoes
 - Pet preparedness
 - o Information and Communication
 - Out-of-area contact cards far out of area, like East coast is best. Have paper card in wallet, as cell phone may have lost power. Make communication plan with family.
 - Red Cross app: Safe and Well (text?)
 - Whistle (tape an extra under desk, so can signal for help if blocked in)
 - Emergency radio
 - Get involved and help each other
 - First Aid training
 - Community Emergency Response Training (CERT)

- 1. Call to Order: Meeting called to order at 1:05 PM by Leslie Anderson.
- 2. Approval of Minutes: The June and July minutes were approved as written. Changes to the August minutes were suggested. The minutes were approved as amended.
- **3. Election Year Timeline:** Emma Alder, EH&S, gave an update of the election progress to the committee.
- 4. Evacuation Drill Subcommittee Report: Leslie Anderson gave an update on the most recent subcommittee meeting. There was a 58% response rate from survey sent out to building coordinators requesting feedback on the current evacuation drill processes. The survey also identified volunteers willing to help with improving these processes and as well as barriers to completing drills. Mark Murray is reaching out to peer institutions to get an idea of how other universities conduct their drills. The committee is looking into centralized scheduling of drills as an option for the future. Another idea is to group buildings for drills but there will be challenges with this strategy. Leslie has meeting with Interim Provost on October 6th. One of the agenda items is discussing the goals and progress of this subcommittee.
- 5. Aging Fire Alarm Systems: Mark Murray, EH&S Building and Fire Safety, discussed aging fire alarm systems on campus. He explained fire alarm system requirements and there are some small buildings where fire alarm systems are not required. He then gave an overview of the UW Alert communications systems, present in many UW buildings, and showed the inventory of small buildings with aging systems or no fire alarm system. Mark explained the costs associated with updating aging fire alarm systems and the funding gap that exists. He discussed different options for deciding how to approach the issue of aging fire alarm systems and asked the safety committees for feedback. Leslie will send out the presentation to the committee chairs and recommend that the committees review the buildings under their purview, discuss them, and respond back to Mark or Leslie.

6. Organizational Group Reports:

- a. **Group 1:** Ryan Hawkinson reported that they met this morning, with a quorum and approved minutes from previous meetings. The group discussed the upcoming election. An e-mail will soon come from the Office of the Provost encouraging election participation.
- b. **Group 2**: Jim Bals reported that Group 2 met and reviewed OARS reports. Some members who are working at Roosevelt Commons, a leased building, have raised electrical outlets. These outlets create a trip hazard. He also discussed a possible evacuation issue in the elevator lobby of Roosevelt Commons. When the fire alarm goes off, someone may not be able to leave the lobby area without key-card access. Another member stated that the doors will unlock when the alarm goes off.
- c. Group 3: Sara Jones gave an update on the Group 3 meeting. There is one new nomination and several members who are going to renew their nominations. The group discussed the accident reports. Housing & Food Services (HFS) now has a mandatory glove policy for their employees. HFS is retraining people to use gloves and is in the process of getting all the right kinds and sizes. There is member on the Group 3 committee, Kara Carlson, who is in charge of safety for HFS. The group then discussed L&I inspections and the recent building coordinator summit.
- d. **Group 4:** Nadia Khan reported that Group 4 reviewed accident reports and discussed upcoming fire drills at their most recent meeting. The current location is not accessible to the staff and needs help to determine a new location more appropriate for the building.
- e. **Group 5:** Liz Kindred reported that 180 incidents occurred within the medical centers in July. The group discussed a concern with the difficulty of moving ICU beds and how to prevent ergonomic injuries related to this task.
- f. **Group 6:** Emma Alder reported that Group 6 meet in July in a new meeting location. The group reviewed their accident reports and are still waiting for the Dean's Office to appoint an election coordinator.
